Neighborhood Memories

Part six of an on-going series about memories of our neighborhood from the old days.

Shopping in the day required special preparation. The vehicles were all prewar and the headlights were required to be painted half-black to thwart the enemies. Each car had a sticker either A, B or C which signified the level of gasoline which was allowed. The food purchases were also circumscribed by a ration book. Only so much sugar and meats etc were allowed based on the ration books which the merchants followed unless they were given under the table rewards which induced a little flexibility. The meat purveyor in the neighborhood was Mert's Market on Pico and Prosser where the goods were always top quality. Down the corner

on Prosser was the George Katz barber shop. He had a great collectable and traditional barber pole which thieves regularly stole. Speaking of crimes the neighborhood did not have many memorable events aside from the pigeon stealing from the hobby coops, and of course shop lifting among the kids was a bit of an epidemic. However the papers were full of Los Angeles gore including The Black Dahlia (Elizabeth Short) whose murder is not solved to this day; there was the notorious Fred Strobel who killed a young girl scarily close to Pasteur Junior High School (now the home of LACES); and others as needed to keep the evening papers selling.

Aside from the local produce stores most of the serious shopping was done at Bullock's Wilshire and if that was a little far and too elegant there was Desmonds in Westwood. There was also Coulters and if George Katz was a little down market for the hair cuts, there was always the Blue and Gold in Westwood and a bunch of men's stores where the well-dressed upgraded from the fare at Ohrbach's. And the transportation to these places were public and relatively safe. The sports fans among us could take the buses to see the midget auto races at Gilmore Stadium (where the profootball Los Angeles Bulldogs also played) and the Gilmore Field where the local minor league team the Hollywood Stars played. Those stadia are now covered by the Grove. An interesting side light on the Hollywood Stars is that its broadcaster in the day was almost as popular as Vin Scully today. His name was Fred Haney and he would give a word picture of what was happening on the field and his own

insights. In fact he seemed so knowledgeable about the game that the owners of the team took him from the broadcast booth and made him the manager. He did not do so well but his signature line on the radio works for this piece: I'm rounding third and heading for home.
