Escrows

An escrow is an independent third party that owes fiduciary duties to carry out instructions in the closing of a real estate transaction. So that monies for a purchase are not taken by the seller prior to the buyer being assured that he will have title as promised, an escrow agent is generally used for the purpose of transmitting purchase funds simultaneously with the recording of the transfer deed. There are escrows that are licensed by the California Department of

Business Oversight called licensed escrows and other escrows which are usually outside the licensing requirements of the Department of Business oversight generally called controlled escrows. Because the escrow is holding monies that belong to others it is prudent to be aware of the escrow which is handling your transaction and under what licensing authority, if any. In general it may be safer to utilize a licensed escrow however the important thing is not to accept just any escrow without an awareness of its business history.
